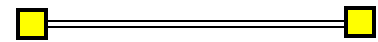

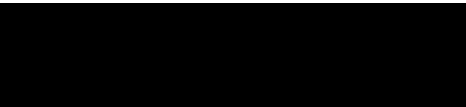

October 9 – March 6

This exhibition addresses one of the more critical issues now facing many cities worldwide: the need to create large-scale development that is energy efficient, helpful for inhabitants, and economically viable. At the outset of the 21st century, the goal of creating environmentally sustainable architecture has never seemed more important or more urgent. This exhibit explores how skyscrapers and other mega-structures are being re-imagined to consume less energy and utilize renewable materials and resources. Mill Stream Run Reservation

I-71..... FROM THE SOUTH

- exit at Rt. 82 (Royalton Rd.)*
- turn right (east) on Rt. 82
- Mill Stream Run Reservation entrance is 1 mile

NOTE: Turn left (north) on Valley Parkway for Albion Woods

I-71..... FROM THE NORTH

- exit at Rt. 42 (Pearl Rd.)*
- turn right (south) on Rt. 42
- continue 1.5 miles

NOTE: Go past the "on" ramp for Exit 10 of the Turnpike which is the entrance point for Ranger Headquarters. Mill Stream Run Reservation entrance is the first traffic light south of the Exit 10 ramp. Turn left (east) Albin Woods

TURNPIKE..... EXIT 10

take Rt. 42 (Pearl Rd.) south (see notes above)

MILL STREAM RUN RESERVATION/ BERA AREA

I-71..... FROM THE NORTH OR SOUTH

- exit at Bagley Rd.
- go west on Bagley Rd.
- continue west past Front St. and Rocky River Dr.
- Mill Stream Run Reservation entrance is on left (Rocky River Reservation is to the right)

TURNPIKE..... EXIT 10

take I-71 North (see I-71 directions)
